The countywide average percentage of salary that is paid in addition to regular wages as fringe benefits is 51%. Fringe benefits include medical and life insurance, retirement, unemployment insurance, workers compensation, and employer's share of FICA. **85% of Social Services salaries are reimbursed by federal/state to the county.** No fringes are paid on Extension Agents by the county. District Attorney's office fringes are paid to the office of the District Attorney and are included in their salaries.
